Taking a more ethical approach

- Boxes from our suppliers are reused in the warehouse where possible
- All waste cardboard and plastic is baled on site for greener transportation and recycling
- Cardboard, plastic, cans and paper are recycled
- We endeavour to have a zero to landfill policy on waste
- We have installed solar panels to the roof of our warehouse to offset our usage of electricity
- Power sockets and unnecessary lighting are switched off when not in use

Our employee Staff Forum Team arrange a number of charity events throughout the year and all monies raised are given to the annually selected employee charities, chosen each year through an employee majority vote. We also support large charity events including Children in Need and Red Nose Day – we love any excuse to wear fancy dress!

Modern Slavery and Human Trafficking

PenCarrie is absolutely committed to preventing slavery and human trafficking in its corporate activities, and to ensuring that its supply chains are free from slavery and human trafficking. The PenCarrie supply chains include the sourcing of high quality lines of clothing and accessories for distribution.

Suppliers are required to demonstrate that they act ethically and within the law in their use of labour. Where suppliers are unable to demonstrate this standard, the organisation will look to terminate the business relationship.
